Stage 1 Level 7 Diploma in Business Management

The Level 7 Diploma is designed for those working in business management or other sectors with a responsibility for management and leadership. The Diploma is awarded by Learning Resource Network (LRN), an Ofqual (UK Government) recognised Awarding Organisation (exam board).

Stage 2 Chartered Manager

When you have passed your Level 7 Diploma, you are entitled to apply to become a Chartered manager, from the UK's highly respected Chartered Management Institute (CMI), on the basis of your professional qualification.

Stage 3 Master's Degree

The Level 7 Diploma gives you enhanced entry onto the degree. You then simply need to successfully complete a dissertation from Bucks New University to obtain your Master's Degree

The International MBA is designed to accelerate the careers of those who are either looking to start in, or already have, career in the creative industries. It provides vocational and academic challenges, presenting you with a holistic approach to your business practice. It is designed to prepare you with the key attributes expected of senior managers and executive staff, whilst also providing the necessary skills to support your creative entrepreneurial ventures.

Units

Level 7 Diploma in Business Management (the six units as above) and Dissertation.

Information

Entry Requirements

To apply for the Level 7 Diploma, you must have either a Level 6 Diploma (or UK equivalent) or at least five years' managerial experience. You must pass the Level 7 Diploma before you can progress to the MBA.

For students whose first language is not English, a certificate is required as a piece of evidence of the necessary level of English. For postgraduate study an average IELTS score of 6.0 (TOEFL 550; CBT 213) or equivalent is required.

All applications for the International MBA are subject to final approval by Bucks New University.

Location and timescales

The five Diploma units are taught in successive short three-day blocks by unit in a local classroom followed by six weeks in your home country while you complete your studies and the assessment. The International MBA dissertation is completed in your home.

Tuition

This package is taught through blended learning which combines classroom tuition with additional online supplementary material and the support of your personal tutor.

Assessment

The five Diploma units are each assessed by an assignment. The International MBA units are assessed by coursework.
